## Location

The 6<sup>th</sup> Annual One Bridge Folk Art Festival takes place in the parking lot adjacent to Winder Binder Gallery & Bookstore at the foot of the historic Walnut Street Bridge, located in the NorthShore district across the Tennessee River from Ross' Landing/Tennessee Aquarium and adjacent to Coolidge Park. This two-day event coincides with Wine Over Water, a premiere wine-tasting event on the Walnut Street Bridge that annually draws a sellout crowd of 6,000.

## General Rules

- Spaces are strictly 10' x 10'. Double spaces are available.
- Display spaces are on a paved surface, so please bring appropriate weights for tents. Be prepared for the weather by bringing adequate protection for your booth.
- For security reasons, we request that all tents be wrapped on all four side (whether with side walls or even a simple sheets or tarps) at the end of day 1 for overnight protection.
- This event will proceed rain or shine. No rain date, no cancellations, no refunds.
- Limited electricity is provided. This event will go into the early evening. Please bring appropriate lighting for your tent. Please use on compact fluorescent bulbs. Some lighting is available from the Gallery, please make arrangements in advance.
- Pets are permitted in at the event. If you bring a pet, clean up after them (and keep them leashed).
- Security personnel will be provided and all reasonable care exercised, including closing the entire event space at night. But the management of Winder Binder Gallery and One Bridge Folk Art Festival shall not be held responsible for loss or damage to merchandise or for injury to anyone participating in the show.
- All artwork must be original in design and displayed by the artist.
- Artists are responsible for collecting sales taxes.

## Applying

Non-exempted artists (those who have not participated in a Winder Binder sponsored event in the past) must apply by submitting 3 photos of work and a short bio. A jury of three qualified artists and/or art professionals will oversee applications and review them in the order they are received. When 25 artists have been selected, no more applications will be accepted.

Photos may be submitted in the following ways: 1) they may be emailed to [winderbinderart@comcast.net](mailto:winderbinderart@comcast.net), 2) photos may be sent with the application, 3) a CD-Rom may be sent with the application.

## Fees

- Booth Fee \$95.00 (including electricity and security fees)
- Additional Booth Space (10' x 20' total) +\$60.00
